Privacy Policy

1. Introduction

Welcome to **Stang Hub**. We respect your privacy and are committed to protecting any personal information you choose to share with us.

2. Information We Collect

We may collect information including:

- Name
- Email address
- Phone number
- Vehicle information (optional)
- Social media usernames (optional)
- Photos or videos submitted by members
- Information voluntarily provided through our website, registration forms, or social media.

3. How We Use Your Information

We use your information to:

- Communicate about club events and cruises.
- Register participants for events.
- Send club announcements.
- Improve our services and member experience.
- Share club-related photos and videos (unless otherwise requested).

4. Information Sharing

Stang Hub does not sell your personal information. Information may only be shared:

- When required by law.

- With service providers that assist in operating our website or communications.
- With your permission.

5. Media Release

By participating in Stang Hub events, you acknowledge that photographs and videos may be taken. Stang Hub may use these images for promotional, marketing, and social media purposes without compensation.

6. Data Security

We take reasonable measures to protect your personal information; however, no online system can be guaranteed to be completely secure.

7. Your Rights

You may request that we update or remove your personal information by contacting us.

Terms of Service

1. Acceptance of Terms

By joining, registering for, attending, or participating in any Stang Hub event, cruise, meetup, gathering, or activity, you agree to these Terms of Service.

Participation is entirely voluntary.

2. Independent Participants

Stang Hub is a community organization that brings together automotive enthusiasts.

Each participant operates their own vehicle independently and is solely responsible for:

- Their own driving.
- Their own decisions.
- Their own actions.
- Compliance with all federal, state, and local laws.

Nothing about participating in a Stang Hub event creates an employer-employee relationship, partnership, agency, or joint venture.

3. Driving Responsibility

Every driver is solely responsible for:

- Operating their vehicle safely.
- Maintaining proper insurance.
- Holding a valid driver's license.
- Ensuring their vehicle is safe and roadworthy.
- Following all traffic laws.
- Driving according to current road, weather, and traffic conditions.

Participants are expected to exercise good judgment at all times.

4. Route Information

Stang Hub may provide:

- Cruise routes
- Destination information
- Meeting locations
- Suggested schedules

These routes are provided strictly for convenience.

Drivers are free to:

- Follow the route.
- Leave the route.
- Travel separately.
- Arrive independently.

Stang Hub does not direct or control how any participant operates their vehicle.

5. Assumption of Risk

Participation in vehicle cruises and automotive events involves inherent risks including, but not limited to:

- Vehicle accidents
- Mechanical failures
- Weather conditions
- Road hazards
- Traffic conditions
- Actions of other drivers
- Property damage

- Personal injury
- Death

By participating, each individual voluntarily assumes all risks associated with attendance and participation.

6. Release of Liability

To the fullest extent permitted by applicable law, participants agree that Stang Hub, its owners, organizers, volunteers, officers, members, sponsors, and affiliates shall not be liable for any:

- Vehicle damage
- Property damage
- Personal injury
- Death
- Financial loss
- Traffic citations
- Insurance claims
- Mechanical failures
- Towing expenses
- Lost wages
- Medical expenses
- Acts or omissions of any participant
- Acts of third parties

Each participant expressly releases and discharges Stang Hub from any liability arising out of participation in any club activity.

7. No Responsibility for Driver Conduct

Stang Hub does not supervise, direct, encourage, or control the driving behavior of participants.

Each driver acts independently.

Drivers are solely responsible for:

- Speed
- Following distance
- Lane changes
- Passing
- Traffic violations
- Racing
- Burnouts
- Drifting
- Reckless driving

- Any other driving behavior

Any unsafe or illegal driving is the sole responsibility of the individual driver.

8. No Organized Racing

Stang Hub does not organize, encourage, promote, or participate in illegal street racing, exhibitions of speed, reckless driving, or any unlawful activity.

Participants are expected to obey all applicable laws.

9. Vehicle Condition

Each participant is solely responsible for ensuring that their vehicle is:

- Properly maintained
- Properly registered
- Properly insured
- Safe to operate

Stang Hub performs no inspections and makes no guarantees regarding the condition of any vehicle.

10. Insurance

Each driver is responsible for maintaining all legally required automobile insurance.

Stang Hub does not provide insurance coverage for participants or their vehicles.

11. Indemnification

Participants agree to defend, indemnify, and hold harmless Stang Hub, its owners, organizers, officers, volunteers, and affiliates from any claims, lawsuits, damages, liabilities, costs, or attorney's fees arising from their participation or conduct.

12. Removal from Events

Stang Hub reserves the right to remove or refuse participation to any individual whose behavior is unsafe, illegal, disruptive, or inconsistent with the values of the club.
